Homeowner *Road Home* Accomplishments to date: October 31st , 2016

- 130,062 homeowners have had their benefits calculated and of those, 130,047 (99.99%) homeowners have closed on their Road Home grant with disbursements totaling \$9,014,135,365. The average award is \$69,314.
- 119,226 (92%) of these homeowners have decided to stay and rebuild in Louisiana. Rebuilding resources provided to Option 1 homeowners totaling \$8,090,152,330. The average award is \$67,856.
- 61,690 additional disbursements have been closed for a total of \$1,721,320,184. The average additional disbursement is \$27,903.
- 54% of all Road Home dollars (\$4,881,275,392) have been provided to 56,143 low to moderate income households. The average award is \$86,944.
- 46,143 homeowners have received \$2,126,633,778 in Additional Compensation Grants (ACG) to supplement their recovery needs.
- 30,033 elderly applicants have closed for a total of \$2,405,453,545. The average award is \$80,094.
- 17,592 disabled (self-reporting) applicants have closed for a total of \$1,307,728,702. The average award is \$74,337.
- BRGA funding has been provided to 488 homeowners totaling \$16,137,467.
- IMM funding has been provided to 25,730 homeowners totaling \$192,741,891.
- 64% of the 111,317 applicants monitored through this period have been dispositioned Compliant. 35 of the 37 work-in-progress parishes have greater than 40% compliancy.
- 32,389 applicants have received elevation disbursements totaling \$942,907,929.
