Homeowner *Road Home* Accomplishments to date: Sept. 30th , 2016

- 130,062 homeowners have had their benefits calculated and of those, 130,047 (99.99%) homeowners have closed on their Road Home grant with disbursements totaling \$9,013,651,953. The average award is \$69,311.
- 119,226 (92%) of these homeowners have decided to stay and rebuild in Louisiana. Rebuilding resources provided to Option 1 homeowners totaling \$8,089,617,810. The average award is \$67,851.
- 61,684 additional disbursements have been closed for a total of \$1,720,833,346. The average additional disbursement is \$27,898.
- 54% of all Road Home dollars (\$4,880,771,506) have been provided to 56,140 low to moderate income households. The average award is \$86,939.
- 46,144 homeowners have received \$2,126,683,778 in Additional Compensation Grants (ACG) to supplement their recovery needs.
- 30,033 elderly applicants have closed for a total of \$2,405,492,690. The average award is \$80,095.
- 17,592 disabled (self-reporting) applicants have closed for a total of \$1,307,716,738. The average award is \$74,336.
- BRGA funding has been provided to 488 homeowners totaling \$16,137,467.
- IMM funding has been provided to 25,730 homeowners totaling \$192,741,891.
- 60% of the 116,770 applicants monitored through this period have been dispositioned Compliant. 35 of the 37 work-in-progress parishes have greater than 40% compliancy.
- 32,389 applicants have received elevation disbursements totaling \$942,907,929.
