
Dear Chairman White:

Attached is a report prepared in accordance with LRS 49:308.3(E) enacted by Act 1127 of the 1995 Regular Session of the Legislature. This report depicts the special funds created in Treasury and includes for each fund the legal citation, date of creation, cash balance in the fund as of the end of the prior fiscal year, and a notation as to whether or not any revenue or expenditure activity has occurred during the prior fiscal year.

There are presently 415 special funds created by the Constitution or statute that are being administered by my office. This represents an increase in the total number of special funds from last fiscal year as depicted on the attached graph.


